4. FIRST AID MEASURES

First aid measures**Skin Contact**

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing before reuse. If irritation persists or burns occur, get medical attention.

Eye contact

Immediate medical attention is required. Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area.

Inhalation

If dust is formed or irritation occurs, leave area and do not return until dust has settled. Give oxygen or artificial respiration as needed. Call a physician or poison control center immediately.

Ingestion

Rinse mouth. Do NOT induce vomiting. Drink plenty of water. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.
